## **Bryson Energy**

- •Bryson Energy is Northern Ireland's Energy Agency and is part of the Bryson Charitable Group. Its aim is "to secure the support and active engagement of Northern Ireland's energy users, particularly households, in implementing strategies, programmes and measures to combat climate change."
- •Bryson Energy plays a central role in changing attitudes and behaviours and promotes action by householders and not-for-profit organisations.
- •Bryson Energy replaced three previous Energy Agencies which were set up in the 1990s in partnership with DETI's predecessor DED with the financial support of the European Commission under its PERU, SAVE and SAVE II programmes.
- •Bryson Energy employs staff across its three offices in Belfast, L'Derry and Enniskillen.













## Health v Austerity



30% aged over 65 who live in the community fall each year\*

45% aged over 85

Belfast = 270,000 > 65 / 30% = 8,100 falls

Evidence shows falls among older people in NI tend to occur in the vicinity of their homes (garage, garden) rather than inside\*\*

Postponing entry into residential care 1 year through adaptation in the home = £28,080 \*\*\*

Hip fracture at home costs state on average £28,665. Four times the average cost of major housing adaptation or 100 times cost of fitting hand & grab rails \*\*\*

The national evaluation of Partnerships for Older People Projects (2009) low intensity practical support, e.g. Handyperson schemes had highest impact on health related quality of Life









## Help is at Hand

Bryson Charitable Group has been funded by Atlantic Philanthropies' to scope and trial a handyperson service model for Northern Ireland based on a social enterprise approach.

Bryson Energy is delivering this project on behalf of Bryson Charitable Group. The project commenced in April 2013 and is due to be completed by September 2015.

A trial or pilot testing different approaches to charging and delivery is a key element of the work and is designed to inform the future roll-out of the service

## Social Enterprise Model

Definition of a Social Enterprise:

A business with primarily social objectives whose surpluses are principally reinvested for that purpose in the business or in the community, rather than being driven by the need to maximise profits for the stakeholders and owners.















## Social Enterprise Model

Occupant	Charges
Those aged 60 and over and in receipt of benefits	£15 for 3 hours or pro rata
Those aged 60 and over	£30 for first hour and £10 per subsequent hour up to a maximum of 2 additional hours. Total maximum charge
Materials	Supplied by the Occupant
General consumable e.g. glue, nails, sandpaper, tacks, staples,	F.O.C.
